b) The purpose of processing of personal data;

c) The method and legal basis of collection of personal data

Your Personal Data is processed securely via digital and printed methods. Your personal data is processed for the purpose, method and legal reasons stated above.

ç) Transfer of Personal Data

Bank may transfer your above-mentioned personal data to legally authorized public institutions and organizations, judicial and administrative authorities such as prosecutor's offices, courts, law enforcement units, its subsidiaries and business partners for the above-mentioned purposes.

d) Rights of The Data Owner and Exercise of Rights

As personal data owners, if you submit your requests regarding your rights to Bank, Bank will finalize the request free of charge as soon as possible and within thirty (30) days at the latest, depending on the nature of the request. However, if the transaction requires an additional cost, Bank will charge the fee in the tariff determined by the Personal Data Protection Board. In this context, personal data subjects have the following rights;

- to learn whether his/her personal data are processed or not,
- to demand for information as to if his/her personal data have been processed,
- to learn the purpose of the processing of his/her personal data and whether these personal data are used in compliance with the purpose,
- to know the third parties to whom his personal data are transferred in country or abroad,
- to request the rectification of the incomplete or inaccurate data, if any and to request notification of the transaction made within this scope to third parties to whom personal data are transferred,
- To request the deletion or destruction of personal data in the event that the reasons requiring its processing disappear, although it has been processed in accordance with the provisions of the Law and other relevant laws, and to request notification of the transactions made within this scope and in case of incomplete or incorrect processing of personal data to third parties to whom personal data is transferred
- to object to the occurrence of a result against the person himself/herself by analyzing the data processed solely through automated systems,
- to claim compensation for the damage arising from the unlawful processing of his/her personal data.
